RESULT OF VOTING ON THE BUSINESS TRANSACTED AT THE ANNUAL GENERAL MEETING HELD ON 06-08-2025.

The 49th Annual General Meeting of J. B. Chemicals & Pharmaceuticals Limited ("Company") was held on Wednesday, August 6, 2025 at 1.30 p.m. (IST) through Video Conference (VC) / Other Audio Visual Means (OAVM) pursuant to notice dated July 10, 2025 ("Notice") issued to the members of the Company. In accordance with the Companies Act, 2013, read with General Circular No. 9/2024 dated September 19, 2024 and General Circular No. 20/2020 dated May 5, 2020, and other applicable circulars issued by the Ministry of Corporate Affairs and Circular No. SEBI/HO/CFD/CFD-PoD-2/P/CIR/2024/133 dated October 3, 2024 issued by SEBI, annual general meeting of the Company was held through VC/ OAVM. The Company provided remote e-voting facility, electronic voting facility and VC/ OAVM facility to the shareholders for participation in the annual general meeting through National Securities Depository Limited (NSDL) portal.

As per the Companies Act, 2013 and Companies (Management and Administration) Rules, 2014 read with Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company provided remote e-voting facility in respect of all the businesses/proposed resolutions set out in the Notice. The remote e-voting commenced on Sunday, August 3, 2025 at 9.00 a.m. and ended on Tuesday, August 5, 2025 at 5.00 p.m. (both days inclusive). At the annual general meeting, the members who did not vote through remote e-voting, were provided an opportunity to vote, on all the businesses/resolutions set out in the Notice, through e-voting facility after the conclusion of the meeting.
