We wish to inform you that the Board of Directors of the Company has, at its meeting held today approved the Buy-back of up to 33,33,333 fully paid-up Equity Shares of face value of Rs. 2/- each by the Company (representing 3.99% of the total paid-up Equity Share capital of the Company) at a price of Rs.390/- (Rupees three hundred ninety) per Equity Share payable in cash for a total consideration not exceeding Rs. 130/- crores (Rupees one hundred thrity crores only) (excluding transaction costs such as fees, brokerage, taxes, duties, etc), which is not exceeding 10% of the total paid-up Equity Share capital and free reserves (including securities premium account) as per the audited financial statement of the Company for the financial year ended on March 31, 2018, through the "Tender Offer" route as prescribed under the Securities and Exchange Board of India (Buy-Back of Securities) Regulations, 1998 as amended, on a proportionate basis, from the Equity Shareholders/beneficial owners of the Equity Shares of the Company including promoters, members of promoter group and persons acting in concert, as on the record date.

The Board Meeting commenced at 11.30 a.m. and concluded at 1.00 p.m.
